TOURNAMENT RULES

Tournament is open to anyone 18 years and older. All participants must be USBC certified. **All touring PBA and LPBT members are not eligible for entry in this tournament.** Anyone bowling in three or more pro tournaments in the previous twelve months will be considered a “touring pro”. If you are under 18 you must have a parental consent form filed with tournament officials prior to start of bowling. Bowlers shall use their highest current 21 game USBC average as of December 31, 2009 unless the previous year’s average is 10 pins higher; then the highest average will be used. If bowler does not have 21 or more games as of December 31, 2009, then the previous year’s average will be used. Bowlers who do not have an acceptable average as outlined in the tournament rules will bowl “scratch”. Women cannot bowl in the Men’s division, nor can Men bowl in the Women’s division.

Average verification is mandatory for all bowlers. It is the responsibilities of each bowler to report his/her correct average. Failure to use proper average or to make corrections prior to the completion of the first game of the first series shall disqualify the score if the submitted average is lower than the actual average. If submitted average is higher than the actual average; then the scores will be based on the submitted average. USBC rule 319 E will apply and re-rating will follow the procedure outlined in this rule. Tournament directors reserve the right to re-rate or reject any participants. Any re-rate must be reported. Bowlers who have won \$600.00 or more in any one tournament within the past twelve months prior to bowling in this tournament must report scores, position and amount won.

Bowlers will be responsible to make certain that their scores are accurate. Once posted, scores are official. Bowlers may enter as often as they wish but may only “cash” once. All bowlers are requested to check in thirty minutes before squad time. Anyone not checking in fifteen minutes before squad time will forfeit their spot for that squad. No pacers will be allowed. There must be **at least two but no more than six** bowlers per pair of lanes.

Handicap will be based on 70% of 220 for both men and women bowlers. Maximum handicap for men is 49 pins and a woman is 56 pins.

Entry fee must accompany the entry form. Out of town checks or money orders will be accepted with a valid address and phone number. Make checks payable to the Ken Gregory Memorial Tournament. Any returned checks will result in participant being disqualified from the tournament. **ALL PRIZE MONEY WILL BE RETURNED 100% AT A RATIO OF ONE PRIZE PER 10 ENTRIES.** Premature termination of the tournament brought about by war, national emergency, fire, natural disaster or any other reason beyond the control of the Ken Gregory Tournament shall cause, to the extent required hereby, all advertised prizes guaranteed or otherwise, to be pro-rated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination. All general USBC rules apply with the exceptions stated above. **CLOSING DATE AND TIME FOR ENTRIES IS 12:00 P.M. ON APRIL 25, 2010.**
