



## Bidding Rules and Form

### All Requirements below must be in place prior to this bid.

1. Minimum of 16 lanes to host Open Championship. (may be combined with other bidding centers)
2. Women, Youth Scratch Championship, Youth State. (12 lane minimum)
3. **Must follow pre-set dates and times. See below.**
4. All lanes in the center are available for Saturday and Sunday squad times.
5. Must have adequate staff for check in, brackets, and sales of state merchandise.
6. Hotel accommodation for Saturday night are required for tournament director at least 30 days prior to arrival date. If travel is over 2 hours from the tournament director's residence reservations for Friday may be necessary. Expenses for hotel will be held out of lineage check if hotel arrangements are not made by the Proprietor.
7. On site local 50/50, side pots (for adults), and/or bucket raffle may be sold.
8. All lanes and establishments may be pre-inspected at any time prior to the tournament. **Must have working foul lights and pinsetters.** An inspection sheet will be provided to be signed by both the proprietor and tournament director before the tournament starts. A copy of the oil pattern will be provided to the tournament director for them to have available for any bowler who requests it, after completion of the tournament.
9. Wyoming USBC can cancel the contract for hosting any tournament if it is found that the hosting center is having mechanical issues that would affect their capabilities of running full squads. This includes but is not limited to foul lights, pin setters, and scoring. Wyoming USBC has the right to refuse any bid for any reason.
10. \$10 Brackets must be sold by the local association for the Open and Women's Championship. The profit will be split 50/50 with the local association and Wyoming USBC.
11. If more than 49% of ownership changes hands after awarding tournament the board of directors will review the awarded bid on a case-by-case basis.
12. **NO ALCOHOL WILL BE IN THE MAIN AREA OF BOWLING DURING ANY YOUTH EVENT.**
13. Will have office space, internet access, table, and chairs for State director.
14. Food and drinks must be available during tournament time.
15. Proprietor and Local board president must sign this form.
16. All bidders must be financially capable of hosting tournaments. Tournament lineage may be paid up to 30 days after the final squad is bowled.
17. Each center will be responsible for entering all names into computer system, as well as providing the tournament director with a printout of scores once a squad is completed.
18. **All bids are due to tournament committee chairman by Sept 1<sup>st</sup>.**
